SUPER BOWL: DON'T BET ON IT!

SDA staff members and student-athletes are prohibited from betting anything of value (e.g., money) on any sporting event (college, professional, or otherwise), in which the NCAA conducts championships. This includes Super Bowl prop bets and point squares that require entry fees.

NCAA NIL ASSIST

The NCAA in partnership with Teamworks developed NCAA NIL Assist, a platform designed to connect student-athletes with potential service providers, facilitate disclosures of NIL activities, and provide insight into evolving trends with the NIL environment. BENEFITS TO PROSPECT COACHES/TRAINERS



Prospect coaches (and administrators (e.g., high school athletics director)) can only receive two complimentary admissions to regular-season, home athletics events (on a pass list). Prospect coaches and administrators cannot recieve any other benefits including but not limited to: admissions to away games, gear, a round at the bar, free golf, money, or meals.

There are no pre-existing relationship exceptions relating to providing stuff to prospect coaches or administrators. This includes a coach's status as an ASU alumnus in most circumstances.

If you would like to give a prospect coach or administrator something, please check with the Compliance Office.

Institutional/Coach/Staff Member Involvement in NIL:

Coaches and staff are encouraged to read through the NCAA guidance found by clicking <u>here</u> relating to institutional involvement with student-athlete NIL activities as well as with the Sun Angel Collective. Key highlights are:

- 1. Coaches and staff cannot personally donate to the Sun Angel Collective.
- 2. Coaches and staff can purchase a student-athlete's product (e.g., t-shirt) so long as the value is de minimis (e.g., a coach can buy a t-shirt, but a coach cannot buy a box of t-shirts from the student-athlete).
- 3. Coaches and staff can connect a student-athlete with a business owner and facilitate deals between the studentathlete and the business so long as the student-athlete maintains independent authority over the deal.

SPOT THE VIOLATION

Quincy Quarterback and his friends, Randy Runningback and Sammy Safety have been invited to a family Super Bowl party at Quincy's uncle's house. Quincy's uncle has a Super Bowl point square board available with a \$5 per square buy-in. Quincy, Randy, and Sammy each buy two squares to help make the game more enjoyable.



CAMPS AND CLINICS

Any camp or clinic owned by an SDA employee is an institutional camp under NCAA legislation. Noninstitutional camps are those owned or operated by other coaches or groups outside of SDA. The following details some of the main NCAA rules and regulations relating to camps.

Attendance Requirements

- Must be open to any and all entrants (limited only by number, age, grade, and/or gender).
- No free or reduced admission for prospects.
- May invite specific prospects who are eligible to receive recruiting materials (juniors and seniors in high school) provided the camp is legitimately advertised.

Advertisements, Apparel, and Awards

- All camps must be advertised as open to any all for <u>at least 14 days</u> before the start of the camp.
- Camps' may provide apparel and awards to campers, but only if the costs are included in the camp admission
 or registration fees.

Noninstitutional (Outside) Camps

- Coaches and staff must obtain approval from the Compliance Office before committing to work at noninstitutional camps. Please start the process by submitting the TCR Camp/Clinic Request (Outside) workflow.
- Noninstitutional camps must meet all institutional camp legislative requirements (e.g., open to any and all, advertised for at least 14 days, include instruction, etc.).

Student-Athlete Employment

- May work at institutional and noninstitutional camps. NOTE: International student-athletes may NOT work camps because ASU camps are not considered on-campus employment.
- May be featured in camp advertisements (e.g., name, image, likeness) only in the Staff section.
- Must be paid going rate.



GEAR AND PROSPECTS

Generally, institutions may not provide gear to prospects or their guests. If there is a health and safety concern (e.g. extreme rain, torrential downpour), SDA may loan gear on an issue and retrieval basis. The requesting coach or director of ops must fill out checkout and retrieval form and work with the Compliance Office before loans are made.

AND THE ANSWER IS

Because there is an entry fee to participate, the Super Bowl point square is impermissible. SDA staff members and student-athletes are prohibited from betting anything of value (e.g., money) on any sporting event—college, professional, or otherwise—in which the NCAA conducts championships. This includes Super Bowl prop bets and point squares that require entry fees.
