Last week, the NCAA DI Council officially introduced the following proposals into the 2022-23 legislative cycle. The proposals include:

- 1. Eliminating the volunteer coach designation in all sports, thereby making these positions regular assistant coach positions.
- 2. Increasing the number of countable coaches by one in baseball, softball, and ice hockey.
- 3. Removing "makes or assists in making tactical decisions related to the sport during on court or on-field practice or competition" as an element of the definition of a countable coach;
- 4. In football, amending the graduate assistant coach designation;
- 5. In diving, eliminating the graduate assistant coach designation; and
- 6. In softball, implementing midyear transfer restrictions.

The Pac-12 Legislative Council will seek feedback from institutions over the next 2-3 months in preparation for the final vote at the NCAA Convention from January 11-13. The Compliance Office will seek feedback from coaches and staff over the next few weeks.





CIVIC ENGAGEMENT DAY

As a reminder, all CARAs are prohibited on Tuesday, November 8 for the Civic Day of Engagement unless a sport is in its championship segment and follows the parameters in the newly enacted championship segment exception. To use this exception, a sport must give student-athletes a day off between now and November 23. And on this day off, student-athletes must be provided with opportunities to participate in civic engagement activities.

In addition, SDA has developed a civic engagement policy that addresses opportunities available to student-athletes for civic engagement. This was created through a collaborative process involving student-athletes, coaches, and senior administrators to ensure student-athletes are provided adequate opportunities, resources, and programming to participate in civic engagement activities.

RARAs

What is a RARA?	A RARA is any required activity that has any relation to a student-athlete's participation in athletics. For a non-exhaustive list of RARAs, please click <u>here</u> . Notable RARAs include community service events, student host duties, athletically-related travel, team building activities, and media activities.
Definition of "required"	An athletically related activity is "required" when the activity is initiated, organized, or witnessed by anyone in SDA. Thus, the definition of voluntary under RARA legislation is slightly different (and narrower) than under CARA legislation. Even if student-athletes want to participate in a community service event organized by SDA or attended by a staff member, they cannot participate in the event on an off day or if the event is not included on their sport's ARMS calendar.
When are RARAs prohibited?	Student-athletes are prohibited from participating in RARAs on all off days and during an 8-hour, overnight period between 9:00 pm and 6:00 am.
ТМР	Please remember to provide student-athletes with proper notice of CARAs and RARAs throughout the year in accordance with the sport's time management plan.

Basketball NLI signing dates: November 9-16, 2022 and April 12 through May 17, 2023

COMPLIMENTARY TICKETS

Player Guests

Student-athletes in ticketed sports may receive complimentary tickets for home and away events in their sport.

Deadline: Home and away games – 11:59 pm two days before game day, or Thursday at 11:59 pm for any Saturday or Sunday game. Example: If game day is Thursday, November 17, the deadline is Tuesday, November 15 at 11:59 pm.

Process: Student-athletes add their guests to ARMS using the "Complimentary Tickets" tab. The tip sheet <u>here</u> contains the step-by-step process student-athletes must follow to properly submit requests.

Prospects

Deadline: Regular season home events only – 11:59 pm two days before game day or Thursday at 11:59 pm for any Saturday or Sunday game. Example: If game day is Thursday, November 17, the deadline is Tuesday, November 15 at 11:59 pm.

Process: Tickets are requested through the prospect's ARMS profile. Tickets for staff and student hosts accompanying the recruit must be requested separately via the staff or student ticket request processes. An official or unofficial visit request must be submitted before requesting complimentary tickets for a prospect.

AND THE ANSWER IS

An NCAA rule exception allows a sport participating in the championship segment to participate in CARAs on November 8, provided student-athletes are given a day off from CARAs to participate in civic engagement activities by November 23. Here, Argon baseball was not in its championship segment, so November 8 should have been an off day for civic engagement activities. In addition, had the baseball program been in its championship segment, there is no indication the sport offered civic engagement opportunities for its student-athletes on the off day.
